ITEM 4 WARREN WAR MEMORIAL SWIMMING POOL SHADE COVERS

(S19-2)

RECOMMENDATION

- 1. That Council approve the purchase of a PVC water resistant shade cover for the deep end of the Main pool at \$92,960;
- 2. That Council purchase an open weave shade cover for the Wading pool at \$34,210; and
- 3. That Council purchase a PVC water resistant shade cover for the viewing area \$61,570.

PURPOSE

To advise Council that prices have been received for the shade covers as discussed by Council at the Warren Pool complex.

BACKGROUND

Council's Sporting Facilities Committee and the Council have allocated funding from the drought funding grant and from internal resources for the pool improvements.

REPORT

This report is to advise council of the cost of undertaking shade cover works at Warren Pool.

Council has received the following costs to purchase and install shade covers at the deep end of the pool being of PVC water resisting covering, an open weave shade cover at the wading pool end and a PVC shade cover for the western viewing side of the pool.

Council also requested a cost for an open weave shade structure at the deep end of the pool as shown below.

Council has allocated \$100,000 from drought grant funds for shade covers. Additional funding is required to come from the Warren Pool loan to cover the cost.

FINANCIAL AND RESOURCE IMPLICATIONS

Deep end of Pool structures

- PVC Cover and erection cost \$92,960
- Wading pool cover and erection cost \$34,210
- Viewing area PVC shade cover and erection cost \$61,570

Funding is to be provided from the drought grant funds and the Warren Pool loan funds totalling \$188,740.
